## **ORDINANCE NO. 03-20**

## AN ORDINANCE TO ANNEX CERTAIN LANDS TO THE CITY OF WEST LAFAYETTE

WHEREAS, the land described herein is contiguous to the current boundary of the City of West Lafayette; and
