## AN ORDINANCE VACATING A PORTION OF THE RIGHT-OF-WAY OF OLD MCCORMICK ROAD WITHIN THE CITY OF WEST LAFAYETTE

WHEREAS, that portion of Right of Way of Old McCormick Road (the "Right of Way") to be vacated is described in Exhibit A, attached hereto and made a part hereof;

WHEREAS, the "Right of Way" to be vacated is located between and contiguous to lots with Key Numbers 79-06-11-200-009.00-029, 79-06-11-200-013.000-029, 79-06-11-200-015.000-029 in the City of West Lafayette, Indiana, together with any public easements therein, as shown on Exhibit B, attached and incorporated herein;

WHEREAS, the abutting property to said area to be vacated is the property of one sole owner, Franciscan, petitioner for the vacation of the "Right of Way," as shown on Exhibit C, attached and incorporated herein,

WHEREAS, Franciscan, petitioner for the vacation of the "Right of Way", has complied with the provisions of IC 36-7-3;

WHEREAS, Franciscan, petitioner for the vacation of the "Right of Way" requests that the title to the Right of Way be transferred to the abutting landowner abovementioned;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of West Lafayette, Indiana, that:

Section 1. Effective immediately, the Right of Way running between and contiguous to lots with Key Numbers 79-06-11-200-009.00-029, 79-06-11-200-013.000-029, 79-06-11-200-015.000-029 in the City of West Lafayette, Indiana, together with any public easements therein, as described in Exhibit A and shown on Exhibit B, is hereby vacated.

Section 2. The "Right of Way" as described in Exhibit A and shown on Exhibit B, is hereby conveyed to the abutting landowner, Franciscan Alliance, Inc.,

Section 3. This ordinance will be in full force and effect from and after its passage and signing by the Mayor and notice, as provided by law.

Lynn Cason, Jr. Marital Trust as described in Record \#200909025624 in said Recorder's office, South 00 degree 21 minutes 08 seconds West 898.01 feet; thence perpendicular to the north line of the lands conveyed to the County of Tippecanoe as described in Record \#201010023048 in said Recorder's office South 31 degrees 22 minutes 03 seconds East 341.06 feet to said north line; thence along said north line and along the north line of the lands conveyed to the State of Indiana as described in Record \#201010002815 in said Recorder's office South 58 degrees 37 minutes 57 seconds West 436.00 feet, the following six courses are along the remaining courses of the said State of Indiana; South 66 degrees 14 minutes 21 seconds West 311.76 feet; thence North 31 degrees 21 minutes 51 seconds West 119.51 feet; thence South 89 degrees 30 minutes 42 seconds West 24.58 feet; thence North 08 degrees 20 minutes 11 seconds West 65.08 feet to the point of curvature of a curve concave westerly having a radius of 748.85 feet, the radius point of said curve bears South 81 degrees 39 minutes 50 seconds West from said point; thence Northwesterly along said curve 207.55 feet to the point of tangency which bears North 65 degrees 47 minutes 02 seconds East from the radius point; thence North 24 degrees 12 minutes 58 seconds West 343.94 feet; thence North 24 degrees 13 minutes 49 seconds West 836.84 feet to a point on a curve concave northeasterly having a radius of 408.31 feet, the radius point of said curve bears North 65 degrees 46 minutes 11 seconds East from said point; thence Northerly along said curve 74.83 feet to the place of beginning, which bears South 76 degrees 16 minutes 14 seconds West from the radius point, containing 28.30 acres, more or less, subject to easements and rights of way.

Also A part of the West Half of the Northeast Quarter of Section 11, Township 23 North, Range 5 West, Tippecanoe County, Indiana, and being that part of the grantor's land depicted on the attached Right-of-Way Parcel Plat, marked EXHIBIT "B", described as follows: Commencing at the northwest corner of said quarter section designated as point " 210 " on said plat; thence South 0 degrees 09 minutes 22 seconds East 269.56 feet along the west line of said quarter section to the eastern boundary of U.S. 231 designated as point " 1338 " on said plat; thence along said eastern boundary Southeasterly 452.25 feet along an arc to the left and having a radius of 1467.02 feet and subtended by a long chord having a bearing of South 22 degrees 29 minutes 46 seconds East and a length of 452.44 feet to the
point designated " 1058 " on said plat; thence South 31 degrees 22 minutes 00 seconds East 173.52 feet along the northeastern boundary of said U.S. 231 to the point designated "1057" on said plat and the point of beginning of this description: thence South 86 degrees 45 minutes 20 seconds East 114.44 feet along the northern boundary of said U.S. 231 to the point designated " 1056 " on said plat, which point is on the southwestern boundary of McCormick Road; thence South 24 degrees 13 minutes 27 seconds East 214.48 feet along the southwestern boundary of said McCormick Road to a point on the north line of a 3.450 -acre tract as described in Instrument Number 200909020014 in the Office of the recorder of said county, which point is designated " 1346 " on said plat; thence South 23 degrees 55 minutes 35 seconds East 130.78 feet along said southwestern boundary to the point designated " 1210 " on said plat; thence along the western boundary of said McCormick Road Southeasterly 203.13 feet along an arc to the right and having a radius of 789.36 feet and subtended by a long chord having a bearing of South 16 degrees 54 minutes 25 seconds East and a length of 202.57 feet to the point designated " 1211 " on said plat; thence North 31 degrees 22 minutes 00 seconds West 603.65 feet to the point of beginning and containing 0.437 acres, more or less in Parcel 17, and containing 0.338 acres, more or less in Parcel 18; and containing in all 0.775 acres, more or less.
