- 3. That this ordinance shall be in full force and effect from and after its passage.



Ordinance No. 04-17 Exhibit A (Continued) Text of Legal Description for Partial Alley Vacation

Commencing at the southwest corner of Lot 15 in Rising's Addition to Chauncey (now the City of West Lafayette) as recorded in the Recorder's Office of Tippecanoe County, in Book 85, Pages 456 and 457; thence East along the south lines of Lots 15, 14, and 13 a distance of 162 feet to the southeast corner of Lot 13; thence South 12 feet to the Northeast corner of Lot 18; thence West along the north lines of Lots 18, 17, and 16 a distance of 162 feet to the northwest corner of Lot 16 and the east Right-of-Way line of Vine Street; thence North along said Right-of-Way line 12 feet to the Point of Beginning, containing 0.045 acres more or less.
