## ORDINANCE NO. 28-17

## AN ORDINANCE AMENDING ORDINANCE NO. 32-97 BEING THE UNIFIED ZONING ORDINANCE OF TIPPECANOE COUNTY.

Be it ordained by the (County Commissioners of Tippecanoe County, Indiana; the Common Council of the City of Lafayette, Indiana; the Common Council of the City of West Lafayette, Indiana; the Town Council of the Town of Battle Ground, Indiana; the Town Council of the Town of Dayton, Indiana; and the Town Council of Clarks Hill, Indiana), that Ordinance No.32-97, being the Unified Zoning Ordinance of Tippecanoe County is hereby amended as follows:

<u>Section 1</u>: Add the following definition of "Self-storage warehouse business" to **UZO** Section 1-10-2 WORDS AND TERMS DEFINED:

**SELF-STORAGE WAREHOUSE BUSINESS.** A building or buildings designed and used for renting or leasing individual storage spaces accessed by customers from individual inside or outside doors or garage bays to which customers thereof have access for storing or removing their personal property. Individual self-storage spaces shall not be used as a residence or for illegal purposes. All storage shall be indoors.

Section 2: Add the following category to UZO Section 3-2 PERMITTED USE TABLE:

"Self-storage warehouse business"; parking group 13; Special Conditions: 4-9-3-a; allowed by right in the GB, I1, I2, and I3 zones and by special exception in the NB zone.

<u>Section 2a:</u> Eliminate the existing category for Miniwarehouse and self-storage warehousing in UZO Section 3-2 PERMITTED USE TABLE.

<u>Section 3</u>: Change UZO 4-9-3-a TYPE OF BUFFERYARD REQUIRED ALONG A LOT LINE SEPARATING A ZONE UNDERGOING DEVELOPMENT OR REDEVELOPMENT AND AN ABUTTING ZONE by making the following adjustments:

## <u>Section 4</u>: Add to the list in **UZO Section 5-5-6 PERMITTED** *RURAL HOME OCCUPATIONS* the following:

(13) Renting or leasing indoor storage space for large items (boats, RVs, campers, or storage pods, etc.) in a barn or pole barn. All such storage shall be indoors. **Self-storage warehouse businesses** as defined shall not be considered a **rural home occupation**.
