RESOLUTION NO. 21-17

A RESOLUTION AMENDING THE MAP AS CONTAINED IN RESOLUTION 16-16

WHEREAS, the City of West Lafayette did on February 19, 2014 record its annexation ordinance to annex certain land into the City of West Lafayette, some of which lies on both sides of relocated US 231;

WHEREAS, the land use plan for the land annexed into the City of West Lafayette has not been updated since 1981;

WHEREAS, the last Strategic Plan Update for the City of West Lafayette was completed in February 2010;

WHEREAS, the Common Council of the City of West Lafayette did request in a 9-0 vote on May 2, 2016 under Resolution 10-16 that the Area Plan Commission of Tippecanoe County direct its staff to study the US 231 corridor and surrounding land, and that same plan was later amended by the Council on September 6, 2016 under Resolution 16-16 to include additional study areas as depicted on the attached Exhibit A;

WHEREAS, it is now necessary for additional parcels to be added to the study since ownership of those parcels has been transferred from state to private ownership; and

WHEREAS, the area designated on the map attached hereto as Exhibit B depicts both the original and additional areas to be included in the Land Use Plan for the US 231 Corridor.

NOW THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF WEST LAFAYETTE, INDIANA, AS FOLLOWS:

That the Common Council of the City of West Lafayette requests that the Area Plan Commission of Tippecanoe County direct its staff to study the US 231 corridor and surrounding land as shown in Exhibit B and create, with its residents, property owners, and city staff, first a Land Use Plan as an amendment to the Comprehensive Plan for Tippecanoe County, Indiana, and once adopted, a zoning map amendment, consistent with the principals of the Unified Zoning Ordinance, as a means of implementing that Plan, and that the Area Plan Commission, throughout these processes, hold appropriate public hearings to evaluate these proposed work products.


