# Ordinance No. 34-16 Legal Description

Part of Tippecanoe Development II, LLC: Parcel #79-03-31-200-006.000-034 (50.839 ac.) Parcel #79-03-32-100-026.000-039 (5.337 ac.) Parcel #79-03-31-065-003.000-034 (0.002 ac.) Parcel #79-03-32-071-001.000-039 (0.118 ac.)
