ORDINANCE NO. 11-2023 (2nd Amended)

AN ORDINANCE REQUIRING NOTIFICATION TO TENANTS OF DEMOLITION

WHEREAS, Indiana state law on public notice regarding rezoning is detailed at IC § 36-7-4-604.

WHEREAS, Indiana code does not demand, nor does it prohibit the notification of tenants individually of a rezoning hearing that could result in a demolition of a tenant occupied building.

WHEREAS, input from tenants affected by prior rezoning hearings indicates that state provisions do not adequately alert tenants of an upcoming rezoning hearing that could result in a demolition.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF WEST LAFAYETTE that:

The following shall be added to the West Lafayette City Code as Section 28-6 to read as follows.

Sec. 28-6. – Notification of Demolition

It shall be unlawful for any property owner to execute a final demolition order following a rezoning hearing before the West Lafayette Common Council without mailing a certified letter of notification to all tenants in the affected property who will be under lease with the property owner on the date of the rezoning hearing.

- (1) The following conditions are required for the notification.
 - a. The notification must be mailed 21 days prior to the rezoning hearing.
 - b. The notification must include the date of which the ordinance is given a hearing by the Tippecanoe County Area Planning Commission if that date is within the 21-day period outlined in subsection (a).
 - c. The notification must state all information required under IC 36-7-4-604 (b).
 - d. The notification must include a statement outlining the details of the tenant's contract as it applies to potential relocation of the tenant following demolition.
 - e. Property owners are not required to notify tenants of potential subsequent common council meetings where the ordinance is presented on the agenda following the initial rezoning hearing.

- (2) A property owner will be found in violation of West Lafayette City Code if:
 - a. Evidence is found that the property owner did not notify tenants of a rezoning hearing of the property in accordance with section 1.

Violation of this section shall be punishable by a fine in the amount of \$2,500.
