## **RESOLUTION NO. 20-2023**

## A REIMBURSEMENT RESOLUTION OF THE CITY OF WEST LAFAYETTE, INDIANA, DECLARING ITS OFFICIAL INTENT TO REIMBURSE EXPENDITURES FOR COSTS RELATED TO THE CONSTRUCTION OF CERTAIN ADDITIONS AND IMPROVEMENTS TO ITS SEWAGE WORKS SYSTEM

WHEREAS, the City of West Lafayette, Indiana (the "City") intends to provide for the construction of certain additions and improvements to its sewage works system consisting of a combined sewer overflow wet weather facility as more particularly described in <u>Exhibit A</u> attached hereto and incorporated herein by reference (the "Project"); and

WHEREAS, the estimated cost of the Project is not to exceed Thirty Million Dollars (\$30,000,000); and

WHEREAS, the City will use funds on hand of the sewage works to pay for certain costs of the Project; and

WHEREAS, the City reasonably expects to reimburse certain costs of the Project and replenish the funds on hand of the sewage works with proceeds of sewage works revenue bonds (the "Bonds") and, if necessary, sewage works revenue bond anticipation notes (the "BANs"), to be issued by the City pursuant to the provisions of Indiana Code 36-9-23, as amended; and

WHEREAS, the City reasonably expects to issue the Bonds and, if necessary, BANs in an aggregate principal amount not exceeding Thirty Million Dollars (\$30,000,000) for purposes of paying and reimbursing certain costs of the Project;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF WEST LAFAYETTE, INDIANA, THAT the City declares its official intent pursuant to Treasury Regulations Section 1.150-2 and Indiana Code 5-1-14-6(c) to (i) undertake and complete the Project; and (ii) reimburse certain costs of the Project with proceeds of its Bonds and, if necessary, BANs in an aggregate principal amount not exceeding Thirty Million Dollars (\$30,000,000) for purposes of paying and reimbursing the costs of the Project. This resolution shall be in full force and effect upon its passage by the Common Council of the City and approval by the Mayor of the City as required by law.

## EXHIBIT A

## Description of the Project

The project includes a new concrete storage basin at the Wet Weather Treatment Facility to provide storage and treatment of approximately 2.5 million gallons of combined sewage that would otherwise overflow to the Wabash River. Treated flow will be disinfected and discharged while flow stored in the basin will be pumped back to the Water Resource Recovery Facility for full treatment. A new diversion structure, pump building, and chemical storage building associated with the new storage basin will also be constructed. The project is a necessary part and final phase of the City's approved Combined Sewer Overflow (CSO) Long-Term Control Plan (LTCP) to significantly reduce untreated wet-weather sewer overflows at CSO Outfall No. 007 located at the Water Resource Recovery Facility. A new Administration and Laboratory Building will be located near the facility entrance which will include additional office and storage space, an updated laboratory, and new industrial pretreatment program facilities to meet the growing needs of the wastewater utility staff.
