RESOLUTION NO. 12-15

RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF WEST LAFAYETTE, INDIANA AUTHORIZING THE CITY ATTORNEY TO EXERCISE THE CITY'S POWER OF EMINENT DOMAIN

WHEREAS, the Common Council of the City of West Lafayette, Indiana established a Redevelopment Commission ("RDC") and Department of Redevelopment by Ordinance No. 6-89; and

WHEREAS, the RDC established the Levee/Village Redevelopment Area on February 26, 1990 by Resolution No. 3-90; and

WHEREAS, the RDC expanded the Levee/Village Redevelopment Area on April 18, 2012 by Resolution No. RC2012-4 ("Levee TIF"); and

WHEREAS, the Levee TIF includes a parcel of real estate more particularly described on Exhibit A attached hereto and made a part hereof ("Parcel"); and

WHEREAS, the RDC has determined that it is necessary for the City to acquire the Parcel for a public project in the Levee TIF; and

WHEREAS, the owner of the Parcel is Abby Manor Acquisitions, LLC ("Owner"); and

WHEREAS, the RDC, acting by and through the Office of the City Engineer made an offer to acquire the Parcel from the Owner; and

WHEREAS, the Owner rejected said offer;

WHEREAS, pursuant to I.C. 36-7-14-20, the RDC has requested the Common Council to adopt a resolution to exercise the City's power of eminent domain to acquire the Parcel and direct the City Attorney to file a petition in court to acquire the Parcel.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of West Lafayette, Indiana, as follows:

1. The Common Council considers it necessary that the City acquire the parcel of real estate described on Exhibit A, attached hereto and made a part hereof, by the exercise of its power of eminent domain on behalf of the West Lafayette Redevelopment Commission.

2. The City Attorney is hereby directed to file a petition in the Circuit or Superior Courts of Tippecanoe County, Indiana in the name of the City on behalf of the Redevelopment Commission and to take any other action under the laws of the State of Indiana and City of West Lafayette to effectuate the acquisition of the Parcel.
