

RESOLUTION NO. 23-15

A RESOLUTION TO APPROPRIATE THE BUREAU OF JUSTICE BODY-WORN CAMERA PILOT IMPLEMENTATION PROGRAM GRANT

Whereas, the West Lafayette Police Department has been awarded a United States Department of Justice Edward Byrne Memorial Justice Assistance grant for the FY15 Body-Worn Camera Pilot Implementation Program; and

Whereas, federal funds in the amount of \$12,166 will be provided for an acquisition of body-worn camera equipment and an appropriation is necessary to expend the grant reimbursement; and

Whereas, the Police Department has sufficient appropriations to provide the local match of \$10,428 for acquisition of body-worn camera equipment and \$2,340 for required travel activities;

NOW THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF WEST LAFAYETTE, INDIANA, THAT:

SECTION 1. The FY15 BJA Body-Worn Camera Pilot Implementation Program award is appropriated in the General Fund as follows;

Account No. 27000000-545800, Police – Other Equipment	<u>\$12,166.00</u>
TOTAL CAPITAL OUTLAY:	\$12,166.00

SECTION 2. Expenditures to carry out the purposes of the grant shall be reimbursed to the extent authorized by the approved grant agreement.

SECTION 3. The West Lafayette Police Department will adhere to all administrative requirements of the grant and make all required reports.


SECTION 4. This resolution shall be in full force and effect after its passage and signing by the Mayor.


