## **RESOLUTION 28-15**

## A RESOLUTION APPROVING AN AGREEMENT BETWEEN THE CITY OF WEST LAFAYETTE REDEVELOPMENT COMMISSION AND THE INDIANA ECONOMIC DEVELOPMENT COMMISSION TO ESTABLISH A CERTIFIED TECHNOLOGY PARK

WHEREAS, Indiana Code 36-7-32, as amended "(Act"), authorizes a redevelopment commission and the legislative body of a city to enter into an agreement with the Indiana Economic Development Corporation ("IEDC") establishing the terms and conditions governing a certified technology park ("CTP") under §12 of the Act; and

WHEREAS, the City of West Lafayette, Indiana ("City") completed an application to the IEDC to designate a CTP known as the Purdue Research Park Aerospace District CTP ("PRPAD") which application was authorized by the West Lafayette Redevelopment Commission ("Commission") on June 17, 2015 by Resolution No. RC2015-10 and by the Common Council of the City of West Lafayette ("Common Council") on July 6, 2015 as Resolution No. 17-15; and

WHEREAS, said application was approved by the IEDC creating the PRPAD; and

WHEREAS, the Commission negotiated an agreement with the EIDC to establish the terms and condition governing the PRPAD; and

WHEREAS, the agreement establishes a fund under §23 of the Act to receive monies distributed to the Commission and to be expended for the PRPAD, which Agreement is attached hereto; and

WHEREAS, the Commission approved the Agreement at its meeting on November 18, 2015 as Resolution No. RC2015-17.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF WEST LAFAYETTE that:

1. The Common Council hereby approves the Agreement and authorizes the Mayo
