

ORDINANCE NO. 31-14**AN ORDINANCE TO SET THE SALARIES OF THE ELECTED OFFICIALS, CITY OF WEST LAFAYETTE, INDIANA, FOR THE YEAR 2015**

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF WEST LAFAYETTE, INDIANA:

SECTION 1. Purpose

That the purpose of this ordinance is to set the salaries of all elected officials for the year 2015. (I.C. 36-4-7-2)

SECTION 2. Fixed Salaries

That the total salary to be paid to each named elected official for the year 2015 shall be:

Position	FLSA	Biweekly (\$) General Fund	Biweekly (\$) Wastewater Treatment Utility
Mayor	Exempt	1,798.17	1,198.78
Clerk-Treasurer	Exempt	1,667.45	1,111.64
City Judge	Exempt	793.62	0.00
Councilors	Exempt	Paid \$5,406.04 annually in monthly installments.	

SECTION 3. Meeting Compensation

That an additional \$480.00 shall be appropriated from the General Fund to be used for Meeting Compensation. Such compensation shall be paid to the Area Plan Commission Representative at the rate of \$40.00 per month.

SECTION 4.

This ordinance will be effective for, and including, the pay period ending January 2, 2015, and will continue through the pay period ending December 18, 2015.

SECTION 5.

This ordinance shall be in full force and effect from and after its passage and signing by the Mayor.
