## CITY OF WEST LAFAYETTE COMMON COUNCIL PRE-COUNCIL MINUTES December 5, 2019

The Common Council of the City of West Lafayette, Indiana, met in the Council Chambers at the Temporary City Hall – Former Happy Hollow Elementary School on December 5, 2019, at the hour of 4:30 p.m.

President Bunder called the meeting to order and presided.

Councilor Bunder requested that Grace Curry be added to the agenda as an additional Council appointment for District No. 3 for the Traffic Commission. There were no objections by the Council.

Resolution No. 16-19 A Resolution Requesting The Transfer Of Funds (Prepared by City Controller) [No. of Readings 1 of 1]

Councilor Bunder read Resolution No. 16-19 by title only.

City Controller Gray stated that the initial resolution only had a few items on it. He explained that due to the short amount of time remaining in the year, we began to look at over budget items in other areas. We were able to move all of the major category transfers from one bucket to another with funds that were already available, which alleviated the need to ask for an additional \$360,000.00 appropriation to the budget. Mr. Gray requested approval to amend Resolution No. 16-19 to include the additional line items. The amendment will then eliminate the need for Ordinance No. 29-19.

Councilor DeBoer motioned to amend Resolution No. 16-19, and that the vote be by voice vote. The motion was seconded by Councilor Wang. The motion was adopted

City Controller Gray explained that a second reading for this ordinance is no longer necessary because the amendment on Resolution No. 16-19 was approved. He requested that the ordinance be withdrawn. No public hearing will be necessary.

City Controller Gray stated that this ordinance is providing temporary loans for 2020. This is our normal process at the end of the year, and is for the cash flow issues throughout the year as we are waiting for the tax disbursements to come in from the County. The disbursements are scheduled for June and December 2020.

Clerk Booker stated that this is the annual bond coverage for employees. A blanket bond is done rather than bonding each position. The amount is up to \$750,000.00, which is what we have done the last few years.

There has been some confusion about the dates and times, and what is considered a vacancy. Mr. DeBoer brought up that he read that the student rental report only considers it a vacancy if the property has been vacant for the entire twelve months. It is unclear if that is something that the City takes as policy. He questioned what the plan is for housing in District 1, as well as the rest of the city.
