CITY OF WEST LAFAYETTE COMMON COUNCIL PRE-COUNCIL MINUTES OCTOBER 3, 2013

The Common Council of the City of West Lafayette, Indiana, met in Council Chambers at City Hall on October 3, 2013, at the hour of 4:30 p.m.

Mayor Dennis called the meeting to order and presided.
