CITY OF WEST LAFAYETTE COMMON COUNCIL MINUTES OCTOBER 1, 2012

The Common Council of the City of West Lafayette, Indiana, met in the Council Chambers at City Hall on October 1, 2012, at the hour of 6:30 p.m.

Mayor Dennis called the meeting to order and presided.

The Pledge of Allegiance was repeated.

Present: Bunder, Burch, Dietrich, Hunt, Keen, Thomas, and VanBogaert.

Also present were City Attorney Associate Murtaugh, Clerk-Treasurer Rhodes, Public Works Director Buck, Housing Program Coordinator Dixon, Street Commissioner Downey, Human Resources Director Foster, Fire Chief Heath, WWTU Director Henderson, Parks Superintendent Payne, Information Technology Manager Newman, and Police Captain Sparger.

<u>MINUTES</u>

Councilor Keen moved for acceptance of the minutes of the August 30, 2012, Pre-Council Meeting, and the September 4, 2012, Common Council Meeting. Councilor Burch seconded the motion, and the motion passed by voice vote.

COMMITTEE STANDING REPORTS

<u>STREET, SANITATION, AND WASTEWATER TREATMENT UTILITY</u> Councilor Bunder presented this report, which will be on file in the Clerk-Treasurer's Office.

PUBLIC SAFETY AND ORDINANCE

Councilor Keen presented this report, which will be on file in the Clerk-Treasurer's Office.

PURDUE RELATIONS

Councilor VanBogaert reported on events at Purdue University, including an incident at the Krannert School of Management. He explained the incident involved two black students were in the Krannert School of Management's undergraduate library studying when a small group of students entered. After the group left, the two students noticed that someone had written a racial slur on the whiteboard. He reported that a Purdue Police investigation resulted in the individual responsible confessing. The matter has been turned over to the Dean of Students office for disciplinary procedures within the University system. Councilor VanBogaert that this incident lead to over 300 students, faculty, staff, and members of the community attending a forum at Fowler Hall to discuss the issue, with acting University president, Tim Sands, answering questions and engaging in discussion about the appropriate University response to this and a similar incident that occurred last Spring.

Mayor Dennis noted that members of the West Lafayette Police Department attended the forum.

Councilor Dietrich added that the fraternity involved in the incident offered an apology that one of their membership was involved, though it was certainly not a sanctioned event.

Mayor Dennis reported that during the past weekend he attended various walks and gatherings to bring attention to cancer, Alzheimer's disease, and autism, which were incredibly well attended. He noted that this turnout was a proud moment for the community.

PUBLIC RELATIONS

West Lafayette Community Beautification Award

Councilor Thomas presented the West Lafayette Community Beautification Award to Bruce and Carolyn Shertzer, who have lived at 1620 Western Drive since 1960. Carol is the planner and artist of their garden and Bruce is the laborer.

Mr. Shertzer said he appreciated the award, and appreciates what the Council is doing to improve the looks of the City.

In response to an inquiry from Mayor Dennis, Councilor Hunt stated that the emerald ash borer, which attacks ash trees, is a big issue in the City. She mentioned that the Shertzer's live near Summit, which has 44 ash trees, and some of them are going, others have been treated, though it is unclear if treating will save them.

FINANCIAL REPORT

Clerk-Treasurer Rhodes reported that the County Council reviewed the 2013 City budget on September 20, and issued a non-binding review recommending the budget as proposed. Clerk-Treasurer Rhodes also reported that the County Assessor has completed the assessments, and the Form 11's will be sent out later this week, which gives assessment values for property, used for pay 2013. These were assessments as of March 1, 2012. There is a 45-day period for appeal, after which the Auditor will compile net assessed valuation and send that on to the State for approval. We should then get our tax rates on time, by early next year. Clerk-Treasurer Rhodes stated the State Board of Accounts reports for the month of September have been filed with the Council.

Councilor Hunt asked if individuals pay their property taxes in November, and if she was correct that they do not receive another warning, because there is just one billing per year.

Clerk-Treasurer Rhodes said that the second property tax payment installment is due November 10. The Treasurer sends out a billing in the spring, with the coupons used for both the May and November collections.

Councilor Hunt asked if she recalled correctly that we can dip into this loan and take out what we need, and only pay interest on that. She also asked if a decision has been made on what the interest will be.

WWTU Director Henderson responded that officially the interest rate resets each quarter, and the website has not been updated with the current rate. He stated that the rate will not go below 2%, however with the green project reserve initiative, we should have points to reduce that rate to 1.53%.

He announced that they were presented with the Governor's Award for Environmental Excellence in the Energy and Renewable Resources category. This award acknowledged the project and the things done to grow it over the years, including the grease program, and the smaller effort to get residential grease to the Utility with the popular collection bottles. He stated that they are very pleased to be selected for the award this year, which was presented by Rick Bosingham, the Assistant Commissioner of IDEM.

Mayor Dennis stated that this award is a testimony to WWTU Director Henderson's leadership and vision. He stated that we never seem to get appropriate amount of attention to what we are doing environmentally, and generating our own fuel, everything that we burn, is less that goes to the landfill. It is something to be very proud of.
