The Common Council of the City of West Lafayette, Indiana, met in the Council Chambers at City Hall on December 13, 2012, at the hour of 6:30 p.m.

UNFINISHED BUSINESS

Ordinance No. 31-12 (Amended) An Ordinance To Amend West Lafayette City Code Chapter 21 Concerning The Designation Of Council Districts (Submitted by Councilor VanBogaert)

Mayor Dennis read Ordinance No. 31-12 by title only.

Councilor Keen moved for passage of Ordinance No. 31-12 on second and final reading, and that the vote be by roll call. The motion was seconded by Councilor VanBogaert.

Councilor Burch moved to amend Ordinance No. 31-12 by substituting Proposal E for Proposal A, and that the vote be by roll call. The motion was seconded by Councilor Dietrich.

Councilor Burch stated that she makes this request because the Area Plan Commission is non-partisan. They submitted a non-partisan proposal, in fact two of them. They have done this for the City of Lafayette and the County of Tippecanoe.
