## ORDINANCE NO. 14-13 (Amended)

## AN ORDINANCE REQUESTING AN ADDITIONAL APPROPRIATION FOR THE ECONOMIC DEVELOPMENT INCOME TAX FUND, THE GENERAL FUND, AND THE CLERK'S RECORD PERPETUATION FUND

WHEREAS, the City has required specialized professional services for the US231 Corridor Annexation process and for these expenses it has been determined that it is now necessary to appropriate more money than was appropriated in the annual 2013 budget; and

WHEREAS, the City is implementing comprehensive, fully integrated enterprise planning software, and integrated parking ticket and court software to support core City functions and that will enable the City to effectively provide responsive, high quality services to the public and greater transparency in City activities;

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF WEST LAFAYETTE, TIPPECANOE COUNTY, INDIANA, THAT for the expenses of the municipal corporation, the following additional sums of money are hereby appropriated and ordered set apart out of the Economic Development Income Tax Fund and the General Fund for the purposes herein specified, subject to the laws of governing the same:
