## **ORDINANCE NO. 30-13**

## TO AMEND CERTAIN PORTIONS OF THE UNIFIED ZONING ORDINANCE OF TIPPECANOE COUNTY, INDIANA, DESIGNATING THE TIME WHEN THE SAME SHALL TAKE EFFECT.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF WEST LAFAYETTE, INDIANA, THAT ORDINANCE NO. 32-97 IS HEREBY AMENDED AS FOLLOWS:

**Section 1:** Change **UZO Section 5-1-11(g) Elevation of Existing Residences** by amending the following Subsection 1) as shown below:

1) Elevation Standards: Until July 1, 2013 December 31, 2013 July 1, 2014 in all *FP zones* any existing *residence* (excluding *mobiles homes*) that has been *substantially damaged* or suffered *repetitive loss* may be elevated such that the *lowest floor elevation* is at or above the *flood protection grade*.
