ORDINANCE NO. 09-12

TO AMEND CERTAIN PORTIONS OF THE UNIFIED ZONING ORDINANCE OF TIPPECANOE COUNTY, INDIANA, DESIGNATING THE TIME WHEN THE SAME SHALL TAKE EFFECT.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF WEST LAFAYETTE, INDIANA, THAT ORDINANCE NO. 32-97 IS HEREBY AMENDED AS FOLLOWS:

Section 1: Ordinance No. 32-97 of the City of West Lafayette, Indiana, is hereby amended to rezone the following described real estate, to-wit:

A part of the southwest quarter of Section Seven (7), Township Twentythree (23) North, Range Four (4) West, Wabash Township, Tippecanoe County, Indiana, being the Faith Legacy Properties, Incorporated property as described in Document No. 201111018207, recorded October 18, 2011, in the Tippecanoe County Recorder's Office, being more completely described as follows, to wit:
