Section 2: Said real estate is hereby rezoned as follows:


FROM: "R3W" District



(326 S. Chauncey)

A part of lot number fifty-four (54) in Ellsworth's Sub-division of a part of Chauncey, now West Lafayette and described as follows, to-wit:

Beginning at the northwest corner of said lot; thence southeasterly along the north line of said lot two hundred seventy-seven and one-half (277 ½) feet to Salisbury Street; thence southwesterly along Salisbury Street forty-six (46) feet; thence northwesterly to Chauncey Avenue at a point sixty (60) feet southwest of the place of beginning; thence northeasterly along Chauncey Avenue sixty (60) feet to the place of beginning.

ALSO twelve (12) feet off of the entire south side of lot number forty (40) in the Original Plat of Chauncey, now West Lafayette, Indiana.

Said Additions being laid out and platted upon part of the Southeast Quarter of Section Nineteen (19) Township Twenty-three (23) North, Range Four (4) West. Located in Wabash Township, Tippecanoe County, Indiana.

Beginning at a point on Chauncey Avenue, seventy-one (71) feet Southwest of the Northwest corner of said Lot; thence Southwest along Chauncey Avenue seventy-one (71) feet; thence Southeasterly to Salisbury Street to a point one hundred twenty-eight (128) feet Southwest of the Northeast corner of said Lot; thence Northeasterly along Salisbury Street sixty-four (64) feet; thence Northwesterly to the place of beginning.
