### **ORDINANCE NO. 29-12**

## TO AMEND CERTAIN PORTIONS OF THE UNIFIED ZONING ORDINANCE OF TIPPECANOE COUNTY, INDIANA, DESIGNATING THE TIME WHEN THE SAME SHALL TAKE EFFECT.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF WEST LAFAYETTE, INDIANA, THAT ORDINANCE NO. 32-97 IS HEREBY AMENDED AS FOLLOWS:

<u>Section 1</u>: Change UZO Section 1-10-2 Words and Terms Defined, by adding the following definition:

**FARM DRAINAGE TILE CONTRACTOR.** A business which installs and maintains agricultural drainage.

<u>Section 2</u>: Change **UZO Section 3-2 Permitted Use Table**, by adding under SIC 16 the following category:

"Farm Drainage Tile Contractor" with new footnote 66, parking group 6, permitted by the right in the I1, I2, and I3 zones and by special exception in the A zone.

<u>Section 3</u>: Change **UZO Section 3-2 Permitted Use Table**, by adding the following new footnote:

Footnote 66: In the A zone, all work, materials and equipment shall be indoors and on lots with a minimum of two acres in area.

This ordinance shall be in full force and effect from and after its passage and signing by the Mayor.

### Unified Zoning Ordinance Amendment #74 Farm Drainage Tile Contractor

Staff Report October11, 2012

Staff was contacted by a business owner who wants to legitimize his existing farm drainage tile installation business. Currently the ordinance lumps this use in with "Heavy construction other than building construction – contractors" and only allows these farm drainage contracting businesses in the three industrial zones. After several meetings with the business owner as well as meetings with the site's property owner, staff spoke with the County Commissioners and brought a proposed ordinance amendment before the Ordinance Committee of the APC.

Because this business is an agriculturally-related use serving farmers, everyone agreed with staff that in addition to allowing this use in the industrial zones, it should also be permitted in the Agricultural zoning district, but with some stipulations to protect neighboring properties. It was decided it should only be allowed in the A zone with a special exception from the ABZA. It was also decided that a footnote would be added that limits the use to properties of 2 acres in area or larger, and prohibits outside storage of equipment and materials in the A zone.

This proposal received a positive recommendation on September 5, 2012 from the Ordinance Committee and has staff's support.
