WHEREAS, the application for this was filed with the U. S. Department of Housing and Urban Development following authorization granted to the Mayor of the City of West Lafayette by City of West Lafayette Resolution No. 06-12, and

WHEREAS, this application was approved by the U. S. Department of Housing and Urban Development.

NOW THEREFORE, BE IT RESOLVED by the Common Council of the City of West Lafayette, Indiana, that the 2012 Community Development Block Grant funds as filed with the Department of Housing and Urban Development are hereby appropriated for same, as follows:


