

RESOLUTION NO. 19-12

**A RESOLUTION TO INCREASE THE CASH CHANGE FUND FOR
THE CLERK-TREASURER/ORDINANCE VIOLATION BUREAU, THE
WASTEWATER TREATMENT UTILITY, THE TRAFFIC VIOLATION
BUREAU, AND THE CITY COURT**

WHEREAS, due to the change in the fees, fines, and utility bill amounts that are collected at the Clerk-Treasurer's office, there is a need to increase the cash change funds in order to handle cash payments efficiently; and

WHEREAS, the amounts of these cash change funds have not been changed in over twenty years; and

WHEREAS, Common Council may establish or change the amount of a cash change fund according to Indiana Code 36-1-8-2.

NOW THEREFORE, be it resolved by the Common Council of the City of West Lafayette, Indiana that:

Section 1. The cash change funds are increased as specified:


The Clerk-Treasurer shall custody over the above listed cash change funds.




