**A RESOLUTION REAPPROPRIATING THE

WHEREAS, the previous appropriation was approved by the Mayor of the City of West Lafayette and the City of West Lafayette City Council Resolution No. 16-23 and is contingent of the Department of Housing Urban Development's review and

WHEREAS, this application will be approved by the U. S. Department of Housing and Urban Development.
