ORDINANCE NO. 19-22 (2nd Amended)

AN ORDINANCE VACATING A PORTION OF CHERRY LANE AND ACCEPTING AND DEDICATING TO PUBLIC USE A NEW SECTION OF CHERRY LANE IN THE CITY OF WEST LAFAYETTE, INDIANA.

WHEREAS, after due Notice and Public Hearing, the Common Council of the City of West Lafayette did consider on the 6th day of September 2022, the questions of (1) vacating that portion of Cherry Lane within the City of West Lafayette, Indiana, more particularly shown on Exhibit A and described in Exhibit B (the "Vacated Street") within the City of West Lafayette, Indiana, and (2) accepting and dedicating to public use the land more particularly described in Exhibit A (the "Dedicated Street").

NOW, THEREFORE, **BE IT ORDAINED** by the Common Council of the City of West Lafayette, Indiana, that:

Section 1. The Vacated Street within the City of West Lafayette, Indiana, which is described in Exhibit B and shown on the drawing attached hereto as Exhibit A, shall be and hereby is, vacated, set over, and reverted to The Trustees of Purdue University, a body corporate created and existing under the laws of the State of Indiana, or its successor in interest, as the immediate abutting owner of the Vacated Street as shown on the drawing attached hereto as Exhibit A.

<u>Section 2</u>. The Trustees of Purdue University, or its successor in interest, shall not be required to compensate the City for the fair market value of the Street being vacated but shall transfer to the City land to be used to replace the street being vacated.

Section 3. Purdue Research Foundation, an Indiana corporation (formed and existing under the Indiana Foundation or Holding Companies Act, Acts of 1921, ch. 246), at the request of The Trustees of Purdue University, is undertaking an expansion to the Birck Boilermaker Golf Complex (including the Ackerman-Allen Course and Kampen Course); and to provide access to said Golf Complex, The Trustees of Purdue University desires to donate the land more particularly described in <u>Exhibit C</u> and shown on the drawing attached hereto as <u>Exhibit A</u> (the "Dedicated Street") to the City to replace the Vacated Street.

<u>Section 4</u>. The Dedicated Street shall be and hereby is accepted by the City, and is hereby dedicated to public use to replace the Vacated Street.

Section 5. The Purdue Research Foundation shall bear all the cost and expense reasonably necessary to improve the Dedicated Street to provide a suitable replacement for the Vacated Street in full compliance with all City specifications and regulations and all applicable State and Federal laws, rules and regulations. The Vacated Street will be closed as a public way upon its vacation pursuant to this Ordinance. Following the vacation, the Vacated Street will not be closed as a public way until the West Lafayette Board of Public Works and Safety approves the commencement of construction of the Dedicated Street's public way, which approval shall not be unreasonably withheld, conditioned, or delayed. Until such approval, the City shall be responsible for the maintenance, control, oversight, and liability of the Vacated Street as if the Vacated Street was not vacated. Upon completion, the Dedicated Street will be opened and ready as a public way. A schematic drawing illustrating the planned improvement to the Dedicated Street is attached as **Exhibit D**.

<u>Section 6</u>. The Trustees of Purdue University shall use such Dedicated Street as the new access to the Golf Complex to replace the Vacated Street.

<u>Section 7</u>. The Clerk of the City Council is directed to furnish a copy of this Ordinance, duly executed, to the Recorder of Tippecanoe County for recording, and to the Auditor of Tippecanoe County.


