

**ORDINANCE NO. 25-22**

**AMENDING ORDINANCE NO. 33-21  
PROVIDING FOR TEMPORARY LOANS**

Whereas, the Common Council may authorize the transfer of a prescribed amount, for a prescribed period, to a depleted fund in need of money for cash flow purposes from another fund that has sufficient money;

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF WEST LAFAYETTE that:

The City Controller is authorized as of January 1, 2022, to make the following loans from funds having a sufficient balance to funds that are temporarily short in anticipation of tax draws and/or other anticipated funds.

The loans may be drawn as needed up to the maximum amount. All loans are to be repaid by December 31, 2022.

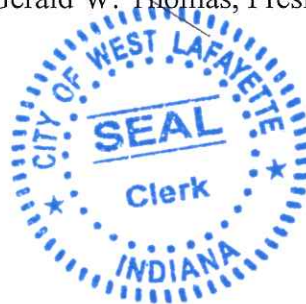
