**A RESOLUTION REAPPROPRIATING THE NECESSARY FUNDS RESULTING FROM THE 2021 COMMUNITY DEVELOPMENT APPLICATION OF THE CITY OF WEST LAFAYETTE UNDER TITLE I OF THE HOUSING AND COMMUNITY DEVELOPMENT ACT OF 1974, AS AMENDED**

**WHEREAS**, the City of West Lafayette did apply for funding under Title I of the Housing and Community Development Act of 1974, as amended, and the regulations set forth in title 24 of the code of federal Regulations as an entitlement city, and

**WHEREAS**, the application for this was filed with the U. S. Department of Housing and Urban Development following authorization granted to the Mayor of the City of West Lafayette by City of West Lafayette Resolution No. 15-21, and

**WHEREAS**, this reprogramming of funds will be approved by the U. S. Department of Housing and Urban Development.

**WHEREAS**, the reprogrammed funds will support the City of West Lafayette's Engineering Department to ensure administrative ADA reporting regulations comply and are meeting industry standards and that those reports are available to the public, acceptable though the Community Development Block Grant program of administrative, planning and technical assistance.
