## **ORDINANCE NO. 14-21**

## ORDINANCE ESTABLISHING STANDARD FINES FOR VIOLATION OF POLICE DEPARTMENT ALARM SYSTEM PROVISIONS OF CHAPTER 8, ARTICLE II, SEC 8-24

WHEREAS, the current West Lafayette Code provides for standard (Non-Ordinance Violation Bureau) fines for the violation of Fire Department Alarm System provisions of Chapter 12, Article II, Section 12-30; and

WHEREAS, the current West Lafayette Code does not provide standard (Non-Ordinance Violations Bureau) fines for the violation of Police Department Alarm System provisions of Chapter 8, Article II, Sec. 8-24; and

WHEREAS, it is found by the Police and Fire Chiefs to be most fair, efficient and effective to have the standard fines for both Fire and Police Alarm Systems violations to be the same.

NOW THEREFORE, be it Ordained the fines for the violation of West Lafayette Code Chapter 8, Article II, Sec. 8-24 (Police) shall be identical to the provisions of Chapter 14, Article XIV, Sec. 14-356 (Fire) to wit:

False/faulty alarms (alarms 4-6 in a calendar year) - \$100 each occurrence

False/faulty alarms (alarms 7-10 in a calendar year) - \$150 each occurrence

False/faulty alarms (alarms 11 and beyond in a calendar year) - \$250 each occurrence
