

RESOLUTION NO. 09-20**A RESOLUTION REAPPROPRIATING THE NECESSARY FUNDS RESULTING FROM THE 2015, 2017, 2018 AND 2019 COMMUNITY DEVELOPMENT APPLICATION OF THE CITY OF WEST LAFAYETTE UNDER TITLE I OF THE HOUSING AND COMMUNITY DEVELOPMENT ACT OF 1974, AS AMENDED**

WHEREAS, the City of West Lafayette did apply for funding under Title I of the Housing and Community Development Act of 1974, as amended, and the regulations set forth in title 24 of the code of federal Regulations as an entitlement city, and

WHEREAS, the application for this was filed with the U. S. Department of Housing and Urban Development following authorization granted to the Mayor of the City of West Lafayette by City of West Lafayette Resolution No. 13-15, 12-17, 11-18, and 06-19, and

WHEREAS, this reprogramming of funds will be approved by the U. S. Department of Housing and Urban Development.

WHEREAS, the reprogrammed funds will support the Small Business Stabilization Fund, acceptable though the Community Development Block Grant program of special economic development for for-profit businesses and microenterprise development.






